



# SAINT BARNABAS CATHOLIC SCHOOL TUITION & PARTICIPATING PARISHIONER FEE POLICY

## I. DEFINITIONS:

### Participating Parishioner -

- a) Regularly attend mass at Saint Barnabas Catholic Church
- b) Registered member with history of tithing at a target of 5% of gross income for the minimum of one full school year as well as a current stewardship intent card completed and on file with the business office representing a target of giving of 5% of gross income.
- c) Actual tithing gifts reflect stewardship pledge.
- d) Must attend mandatory parent meetings annually or as scheduled.

### Non-Participating Parishioner –

- a) Non-members of Saint Barnabas Catholic Church
- b) Catholic families who have recently joined the parish will pay tuition for one full school year before consideration is given to participating parishioner status in subsequent years.

Tuition - Amount required as payment for educational services provided to attend Saint Barnabas School.

Participating Parishioner Fee – Discounted participating parishioner status amount required as payment for educational services provided to attend Saint Barnabas School.

## II. TUITION RATES (Kindergarten – 8<sup>th</sup> grade):

\$6,966	One child
\$13,931	Two children
\$20,897	Three children
\$23,886	Four children
\$29,619	Five children
\$35,668	Six children

\$300 additional fee per student in grade 6 and new students 6-8<sup>th</sup> grade for the purchase of a Chrome Book.

## III. PARTICIPATING PARISHIONER FEE

Participating parishioners regularly attending mass at Saint Barnabas Church and actively tithing a target of 5% of gross income (as per the admissions policy) will receive a tuition discount to arrive at their parishioner fee. Participating parishioner fees are \$1,600 per child in Grades K-5 for the 2023-2024 school year and evaluated annually. Plus, an additional \$300 (one-time fee) per student, grade 6 and new students 6-8<sup>th</sup> grades for the purchase of a Chrome Book.

Participating Parishioner Fees **are due in full** by **May 5th** for the 2023-2024 school year.  
*Please contact the business office at any time if interested in pre-payment for future years.*

## IV. REGISTRATION

A non-refundable/non-transferable registration fee of \$250 per student is due at the time of registration and will be deducted from tuition or participating parishioner fee. *For returning students, any unpaid, lunch accounts, aftercare outstanding balances will preclude your placement on a class list until rectified.*

## V. PRE-K TUITION

Pre-K is a separate program and is funded wholly by tuition. Per child tuition rates for all Pre-K families are as follows:

Monday-Friday full week, all day           \$5,356  
Monday/Wednesday/Friday 3 day, all day   \$3,214

A \$250 registration per student is due at registration and is applied towards total tuition. The balance is due, at the minimum, in 10 equal installments July 2023-April 2024.

## VI. PAYMENT POLICIES:

- A. Participating Parishioner fees must be paid in full by Friday, **May 5** for the 2023-2024 school year.
- B. Tuition and also Pre-K tuition is due, at the minimum, to be paid in 10 equal installments July 2023 through April 2024 or may be paid in full at any time. Statements will be mailed monthly.
- C. All 2022-2023 year Pre-K and Full Tuition balances must be paid in full by April 30, 2023 before a student will be allowed to register and placed on a class list for the upcoming 2023-2024 school year.
- D. All 2023-2024 participating parishioner fees must be paid in full by May 5, 2023, before a student will be placed on a class list for the 2023-2024 school year.
- E. Any exceptions to the above payment plans must be approved by Mr. Hosty, Director of Operations
- F. Participating parishioners who are deemed no longer meeting eligibility requirements as stated in the admissions policy could result in revocation of participating parishioner discount resulting in full tuition.
- G. Catholic families new to St. Barnabas who seek participating parishioner status will pay tuition for one full school year. These families must register as parishioners and fully participate in mass and tithing. Determination as to participating parishioner status will be made the subsequent school year.
- H. Institute for Quality Education Scholarship (SGO) recipients and/or State of Indiana CHOICE Voucher recipients will be responsible for the difference between tuition/fees and the amount of the scholarship and/or voucher.
- I. Late fees can be assessed on unpaid balances and returned check fees assessed for non-sufficient funds (NSF) transactions.
- J. Student Lunches are to be **pre-funded** and not carry balances in the negative. Pay ahead with cash, check or credit card on [www.mymealtime.com](http://www.mymealtime.com). Do not carry borrow balances or your account may be suspended.
- K. Aftercare must be paid weekly. Any overdue balances may suspend your child's participation in aftercare. Any unpaid balances also preclude placement on class lists and result in your status as unregistered until payment is made and the delinquency corrected.

Failure to adhere to the above outlined payment policies could result in a student's removal from school following the notification of failure to comply with payment policies.
